The governing body is responsible for maintenance of this scheme.

1. Introduction: what a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained schools, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- *The classes of information which we publish or intend to publish;*
- *The manner in which the information will be published; and*
- *Whether the information is available free of charge or on payment.*

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is available in paper form.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

2. Aims and Objectives

The school aims to:

- To help pupils acquire knowledge and skills relevant now and to their adult lives, at work and leisure, as consumers and citizens.
- To help pupils develop lively, enquiring minds and a love of learning, the ability to question and argue rationally.
- To develop qualities of spirit, feelings, imagination, a sense of beauty and an appreciation of human achievements and endeavours.
- To engender respect for religious and moral values and to help pupils acquire a reasoned set of attitudes, values and beliefs.
- To develop a sense of self respect, and individual worth, a capacity to live as independent self motivated adults, and the ability to live together.
- To help pupils to understand the world in which they live and the inter-dependence of individuals, groups and nations; to recognise and celebrate the differences that enrich our lives. To develop a sense of responsibility for community and the environment.

The school objectives are:

- That every pupil reaches their full academic potential, and that this should be reflected in excellent examination results.
- That every pupil is enabled to consider their own faith and has the opportunity to develop their relationship with Jesus Christ.

- That every pupil is able to participate in a wide range of activities beyond the curriculum that offer further opportunities for personal growth and success.

This publication scheme is a means of showing how we are pursuing these aims and objectives.

3. Categories of information published

The publication scheme guides you to information which we currently publish (or have recently published) or which we will publish in the future. This is split into categories of information known as 'classes'. These are contained in section 6 of this scheme.

The classes of information that we undertake to make available are organised into four broad topic areas:

School Prospectus – information published in the school prospectus.

Governors' Documents – information published in the Governors Annual Report and in other governing body documents.

Pupils & Curriculum – information about policies that relate to pupils and the school curriculum.

School Policies and other information related to the school - information about policies that relate to the school in general.

Special Education Needs Policy	Information about the school's policy on providing for pupils with special educational needs
Accessibility Plans	Plan for increasing participation of disabled pupils in the school's curriculum, improving the accessibility of the physical environment and improving delivery of information to disabled pupils.
Race Equality Policy	Statement of policy for promoting race equality
Collective Worship	Statement of arrangements for the required daily act of collective worship
